

**The de jure Texian Grand Jury of the People of the republic State of Texas

do hereby issue this

Notice and order to the interim President of the republic for the united States, James Timothy Turner, and the Congress of the republic for the united States

to **cease and desist** from requesting the republic State of Texas House of Representatives or Senate to appear before a Congress of the united States committee to answer questions requiring the members to share facts and circumstances that are the evidence in an ongoing people's Texian Grand Jury November 14, 2010, "Utah Resolution" investigation.

- The Texian Grand Jury deliberations, discussions and investigative proceedings that take place within the session of the Texian Grand Jury are not to be disclosed. They are to remain sealed. Verdicts, Orders and Bills are the only utterances to escape this shroud of protection.
- The Texian Grand Jury, which is one of the people's courts in Texas, is a judicial body of the people that is superior to any court of the Republic for the united States and the republic State of Texas.
- The Texian Grand Jury has requested evidence in the form of the legislative history of the "Utah Resolution" from the Republic for the united State Senate and House of Representatives and continues to wait for this evidence.
- The Texian Grand Jury has accepted the republic State of Texas House of Representatives and Senates Resolution, T.J.R 2011-9-30-1, *Joint Resolution to Join in the Declaration of Trespass With the*


Executive and Judicial Branches Dated May 30, 2011 Against the Congress of the Republic For the united States of America, to join the Executive and the Judicial Branches Declaration of Trespass on the Rights, Privileges and Immunities of the Sovereign Souls of Texas by the Republic for the united States, dated May 30, 2011. This action results in the republic State of Texas House of Representatives and Senate becoming a complainant in the aforesaid Declaration of Trespass.

The Texian Grand Jury compels, with this second notice and order, the production of the Legislative History of the Congress of the Republic of the united States of America to the Texian Grand Jury of the republic State of Texas, of all meeting/meetings held in Utah on November 13th and 14th of 2010, complete with Journals of Proceedings, Recordings, Minutes, Committee Reports, and any other forms of communications of all sessions held at the Wind Walker Guest Ranch, 11550 Pigeon Hollow Road, Spring City, Utah, as well as subsequent records, etc., resulting from/because of the aforementioned meeting concerning the activities on those dates in Spring City, Utah.

The above mentioned items are to be delivered within ten (10) days from receipt of this notice and order at the address given below. Failure to answer with the above items within the required ten (10) days will result in a convening of the Texian Grand Jury to issue a default judgment.
